

# MINUTES OF OPEN MEETING OF BOARD OF COMMISSIONERS BURNET COUNTY ESD NO. 9 February 21, 2024

- 1. Commissioner Bruett called the meeting of the Board of Commissioners of Burnet County ESD No. 9 (BCESD9) to order at 6:00 pm with Commissioner's Steele, Wolfe, Hischar and Price present.
  - Also, in attendance were Lark Camacho (Fire Chief, Spicewood), Derrick Curtis (Fire Marshall, Spicewood) Starla McLaurin (Operations Director, Marble Falls Area EMS), Justin McPherson, Volunteer SFR, Patrick Huber, Firefighter SFR, Brad Wilson, Firefighter SFR, David Bailey (Professional Civic Services) and M Logan (Logan Consulting).
- 2. Pledges to the flags of the United States and the State of Texas were recited.
- 3. Commissioner Hischar gave an invocation.
- 4. Public Comments None
- 5. Presentation Roger Goose, Flexible Water Storage Tanks Mr. Goose gave an overview of his company and background on the flexible water storage tanks. He also stated he had donated a tank to Spicewood Fire Rescue.
- 6. Approval of prior meeting minutes Commissioner Steele made the motion to accept the minutes from January 17, 2024, and was seconded by Commissioner Wolfe. The motion passed with Commissioner Hischar abstaining.
- 7. Monthly Reports
  - a) MFAEMS Operations Starla McLaurin stated it was a busy month. January saw 29 calls with 17 being transported.

- b) Update on Solar Eclipse Planning Area meetings are ongoing, and the board will be kept apprised of any new developments. The event is now 7 weeks out. See attached.
- c) Fire Chief Report January report attached.
  - i. Discuss with possible action on cell tower project David Bailey stated that there was a meeting this date with Patrick King, owner of Nexstream along with Commissioners Bruett and Wolfe as well as Chief Camacho. After discussion it was decided to give Nexstream four weeks to finalize contract. Commissioner Bruett made the motion to give Nexstream four weeks to get service to the tower or the District will find them in default of the contract and was seconded by Commissioner Hischar. The motion passed unanimously.
- d) Fire Marshall Report January report attached.
  - i. Discuss with possible on action on Iron Wolfe Distillery Marshall Curtis stated that Ken Campbell, legal for the District, has sent a letter regarding the required sprinkler system to Iron Wolfe and the process is ongoing. This will be an agenda item for the March meeting.
