

# MINUTES OF OPEN MEETING OF BOARD OF COMMISSIONERS BURNET COUNTY ESD NO. 9 November 15, 2023

- 1. Commissioner Raetz called the meeting of the Board of Commissioners of Burnet County ESD No. 9 (BCESD9) to order at 6:01 pm with Commissioner's Steele, Bruett, Wolfe, and Hischar present.
  - Also, in attendance were Lark Camacho (Fire Chief, Spicewood), Starla McLaurin (Operations Director, Marble Falls Area EMS), Derrick Curtis (Fire Marshall, Spicewood), and M Logan (Logan Consulting).
- 2. Pledges to the flags of the United States and the State of Texas were recited.
- 3. Commissioner Hischar gave an invocation.
- 4. Public Comments None
- 5. Approval of prior meeting minutes Commissioner Hischar made the motion to accept the minutes from October 18, 2023, and was seconded by Commissioner Raetz. The motion passed with Commissioner Bruett abstaining.
- 6. Monthly Reports
  - a) MFAEMS Operations Starla McLaurin stated it was a busy month. October saw 21 calls with 17 being transported.
  - b) Update on Solar Eclipse Planning Director McLaurin gave an overall update on the plans and strategy for the coming eclipse in April 2024. This will be an ongoing agenda item until the event. More information and details as things develop.

#### 7. Treasurer's Report

- a) BCESD9 Financial Review Financial Review was given by Logan Consulting. October 2023 Income \$123,386.75 and Expenses \$117,318.10 with a net surplus \$6,068.65. Total Cash in all accounts \$2,346,175.41. A motion to accept the financial reports from October was made by Commissioner Hischar and seconded by Commissioner Wolfe. The motion passed unanimously. Ms. Logan reviewed the October TexPool report with all commissioners.
- b) Approval of any pending disbursements The paid October disbursements were reviewed with Commissioner Hischar moving approval, seconded by Commissioner Wolfe. The motion passed unanimously. October check detail attached.

### a). Budget & Finance Committee -

i. Update with possible action on Personnel Feasibility Study – Commissioner Hischar made the motion to allow Chief Camacho to move forward with the hiring processes and was seconded by Commissioner Wolfe. The motion passed unanimously. This will be an ongoing agenda item from Chief Camacho at the report level.

### b). Strategic Planning Committee -

- I. Update on selling various apparatus Chief Camacho stated that Brush 91, Brush 95, Rescue 91 and Tender 94 had all been sold for a total of \$44,200.00. Ms. Logan stated that once all the funds have been received, she will transfer them into the TexPool Capital account as per motion from October meeting.
- II. Update on Cell Tower This process is still ongoing. Nothing to update currently. This will be on the agenda until the project is complete.
- 9. Update on SAFE-D Conference and Commissioner Training Ms. Logan stated that the conference is being held in Irving, Texas February 22-24, 2024 and registration is now open. She urged all commissioners to sign up as soon as possible and secure lodging at the hotels suggested by SAFE-D. She gave each commissioner their required hours to be in compliance.
